### Be the Best CFI You Can Be

As a FAA Certified Flight Instructor (CFI) we continually strive to the "best instructor" we can be, seeking as much knowledge, information, skill level and experience as possible. CFI's are the vital link in the advancement and safe training of any pilot. Keeping current and relevant with changes in regulations, technology and equipment can be a daunting challenge - however, a CFI has this responsibility!!

With the availability of the internet almost everywhere today and its incredible span of "information/knowledge", the modern-day CFI has no excuse for a lack of information. The FAA website alone is an extremely valuable resource to the CFI. The FAASTeam has a mission statement of — "lower the Nation's aviation accident rate by conveying safety principles and practices through training, outreach, and education; while establishing partnerships and encouraging the continual growth of a positive safety culture within the aviation community."

### Join the FAASTeam help us make a difference!

To help focus our CFI knowledge, here are three (3) broad traits of a quality flight instructor — Integrity, Communication, and Knowledge. These traits hope to provide some additional insight and information to help ALL flight instructors be their best.

### 1) Integrity

The highest level of integrity provided by a CFI and expected by a student or licensed pilot receiving instruction cannot be overstated – INTEGRITY is an element of instruction that is absolutely essential.

With safety being a principal goal of all flying and in particular flight instruction, CFI's must have their students' best interest and goals in mind. Training, evaluations, comments and critiques must be appropriate, accurate, honest and complete - don't push a recommendation for a Phase Check or a course completion Checkride. Many (if not most) CFI's work as a flight instructor with the objective of one day flying for a major airline - the "1,500 Rule" has made the job of a flight instructor sometimes looked at only a way to accumulate flight time. I've heard many students make the comment that their flight instructor is just wanting to "build time" and is really not interested in actual instruction. A sad reflection on some instructors.

### 2) Communication

Communication styles and the ability to understand that each individual learns differently is something every CFI must recognize and master. Both verbal and nonverbal communication in and out of the airplane is absolutely essential in relating with a student pilot or a pilot on a flight review. Be careful using acronyms, especially with a student pilot, using/talking IFR terminology with a VFR pilot can be confusing and frustrating for the sender and receiver in the communication loop. Communication that is "misinterpreted" can be very costly in lives or equipment.

For example, a CFI instructs a student pilot to "turn 90 degrees" the student may hear this as turn to heading 090 degrees. So, be specific and deliberate in your flight instruction. Communication skills also includes being an excellent listener. My father once told me - "you have two ears and one mouth so, you should listen twice as much as you talk". Listen carefully and deliberately and as a great CFI you must also listen by "watching". Watch for correct

movements and checklist responses with their hands and not just their words. Listen to determine if a student is actually and correctly absorbing the lesson being taught. A CFI has a tremendous responsibility to encourage and help advance a student thru the "curriculum" and a CFI's ability to "communicate" plays a valuable part ...... and a big part of this communication loop is respecting the student.



### 3) Knowledge


It is absolutely essential that as a CFI, you possess the highest level of technical knowledge required for your level of certification coupled with the expected level of instruction you are engaged in. As a CFI, our goal should be to provide an "effective learning experience" — we need to pass on our knowledge to other pilots and help them overcome any fears or weaknesses in knowledge. A CFI must recognize and help a student work past any learning plateau — either a hands-on flying skill or ground knowledge lesson related.

In closing, Flight Instructors have a tremendous level of responsibility to their students and the FBO they fly for — never think **you** can stop learning or stop improving. **Your** Integrity, Communication/Listening Skills and Knowledge are essential to be the best and safest CFI **you** can be !!



### Notice of Revision – FAA Publication

The FAA has published a new version of the Airplane Flying Handbook, FAA-H-8083-3C, now a 2021 publication. The biggest change was the addition of a brand new Chapter 4 – titled "Energy Management"; there are now 18 Chapters in total. Some of the other revisions include: added information on the FAA Wings Program; revised the order in which "Maintaining Aircraft Control" was previously presented; added information on Lazy Eights; remove material on 360 degree power-off landing, as this maneuver is not part of testing standard; address an NTSB recommendation regarding slow spool-up time of split shaft engines.



Additionally, this new revision includes adding, revising information on other subjects in all Chapters except 6, 8, 12, and 17. This new version also corrects various errors in text, figures and graphics. A hyperlink to the new 2021 Airplane Flying Handbook
