GOOD NEWS ON GSLFIA WEBSITE IMPROVEMENTS

It has come to our attention over time that the process of signing up for a new membership, renewing an existing membership, or signing up to take a FIRC was cumbersome and confusing for some. After considerable effort among the GSLFIA Board, and with the help of our Website hoster and developer, Beanstalk Web Solutions, we have a new signup system up and running. In addition, we have reviewed and updated the entire site where necessary.

Without going into the minute details, here are the basics of our new signup system. We have consolidated the main menu FIRC, renewal and initial signup-to-join selections under one single menu selection, "Membership and FIRC". If one makes that selection, they want to do one of three things:

- 1. Join the organization and take their first FIRC free either now or in the future.
- 2. Renew as an existing member and take the next FIRC.
- 3. Just renew as an existing member.

In all three cases, they need to either fill out our instructor information form for the first time or update it with any changes. Therefore, the form is the first thing that comes up. After the form has been reviewed, filled out or updated, one of the three choices above must be selected. Each selection produces a credit card page that makes the appropriate charge for membership and FIRC, produces a thank you page on the screen, and sends emails detailing the transaction to the appropriate board members. Also included automatically, if one elects to take the next FIRC, is a link to the signup system for Aviation Seminars, our FIRC provider and presenter.

As we get closer to the FIRC dates, January 11-12, 2025, we will publish details on how to negotiate the Aviation Seminars signup system and how it is integrated with IACRA.

"The Regs, They Are A-Changing"

Wouldn't you know it, I just learned all of the CFR's (FAR's) that apply to my CFI (It's about time after 47 years as a CFI) and the FAA goes and changes them! Effective 1 December 2024 we're going to have to learn a new set of regulations that change the look of our CFI certificate, the way that we maintain it and the rules that allow us to train initial CFI's.



First of all, a CFI certificate received or renewed after 1 December will NOT have an expiration date printed on the certificate (in line with your Pilot certificate). This is a money saving issue, as the FAA doesn't have to keep printing and mailing our renewed CFI certificate every 24 calendar months. Rather than an expiration date printed on your certificate, now you'll have to meet activity-based requirements to continue to exercise your CFI privileges. For those of us who renew with an FAA approved FIRC every 24 calendar months, we can still use the FIRC to renew our CFI.

For CFI's who are actively instructing they can renew (14 CFR 197) via a FIRC OR recommend at least 5 candidates for a practical test and get an 80% initial pass rate or better. A "big" change is that your CFI does NOT expire at the end of 24 calendar months if, within 3 calendar months after the 24 calendar months you complete the FAA approved FIRC and submit the required 8710 via IACRA.

The old days of having to reinstate your CFI with a practical test only apply if you don't renew WITHIN the 3-calendar month "grace period". If you have an opportunity to teach INITIAL CFI's those rules have changed also. There are now THREE methods to allow you to teach INITIAL CFIs. The old 61.195 requirement of having your CFI for at least 24 calendar months and to have given at least 200 hours of instruction still applies. The NEW allowances are in 61.195 (h) and allows a CFI to train INITIAL CFIs if the CFI has endorsed at least 5 applicants and have an 80% first time pass rate. Lastly, the CFI can graduate from an FAA approved Flight Instructor Enhanced Qualification Training Program (FIEQTP). FAA 141 schools are developing this course to satisfy this new requirement.

This a pretty big change and those of us who don't instruct as much as we used to, should look at the latest Federal Register for the complete ruling and dive back into Part 61 Subpart H to get caught up on these new rules. Thanks for listening and please let me know if I got any of this wrong!!

AVIATION EDUCATIONAL PHILOSOPHY

We frequently hear people discussing teachers and their teaching techniques, as well as coaches and their coaching strategies. But have you ever considered the two terms, which are not interchangeable, similar, or dissimilar? Do these terms apply to your flight students? Broadly speaking, coaching is a holistic, iterative process focused on developing a specific aspect of the person being coached, whereas teaching is a linear, sequential method primarily involving one-way communication, to impart new information.

Coaching and teaching both involve passing on knowledge and skills to others. Both necessitate a certain level of knowledge in the subject matter being taught or coached. Both seek to help people improve or develop in some way. As flight instructors do we find ourselves favoring one pedagogical practice to another? This presentation will examine the similarities and differences between coaching and teaching as it applies to flight instruction.
